### 4. Public Comment:

1. Holly Engel, identified herself as a Township resident, a Township representative on the Kalamazoo Lake Harbor Authority, area business owner, and member of the SDCA. Engel noted that the SDCA was suing the TWP related to a permit issued to the Northshore development to construct a marina, and that a recent circuit court decision has remanded the question of whether the SDCA has standing on the matter back to the Township's ZBA to consider evidence that was not available at the time the ZBA made decisions on standing in 2017 and 2018. Engel looked forward to making a case on standing and sharing evidence to support that position. Engel requested that the Township terminate permits issued to the Northshore development.
