If approved and levied, this millage will raise an estimated \$2,862,780.00 for services to senior citizens in the first calendar year of the levy based on taxable value. This proposal is a renewal of a previously voter authorized millage of 0.493 mills, the revenue from which would be disbursed to the County of Allegan.
